Treasurer's Report:

Current balances are \$3600.30 in checking account

15,019.73 in Money Market account 67,741.05 in 13 month CD (matured) 13,290.65 in 6 month CD (matured) 40.526.15 in 6 month CD (not mature)

The treasurer's accounts are being sent to the auditor approx September 1.

District allotments are ready to send to active districts (4, 5, 6, 7, 13, 16) based on the definition of "active" as having current officers and holding meeting(s) in the previous two years.

A check has been received from the Houston Meeting Committee which included \$1501.44 profit, \$1942.16 advanced, and 3000.00 seed money. A previous check for \$5000 seed money was not used and has been voided.

A motion was made to pay the Executive Secretary for 10 hours worked in June. The

motion was seconded and passed

The Board recommends that the Executive Secretary not work for pay for more than 40 hours per month from TACLS.

The recommendation was made to investigate combining the maturing CD's into one larger CD (approx \$100,000) if higher interest would apply. A comparison of the interest rates of 6, 12, and 18 month CDs was also recommended when reinvesting matured CD's.

The Board of Directors will vote by email on the disposition of monies in maturing CD's.

Web Site Update - Vicki Freeman

Vicki Freeman moved that

business cards be posted on the TACLS web page at a charge of \$25 per month company ads be posted on the TACLS web page at a charge of \$100 per month.

The motion was seconded and passed.

The rights to the TACLS web page domain name was renewed for 3 years at a cost of \$20 per year.

2002 TACLS Annual Meeting

This will be a joint meeting with the Texas Section of American Association of Clinical Chemists who will join us for 1-1/2 days of the meeting. They will provide all of the speakers

for the chemistry section of the program. Tx-AACC will be responsible for 3/8 of expenses and TACLS will be responsible for 5/8 of expenses.

Registration will be \$100 for members, and \$40 for students. Organization membership will be indicated on registration forms. Houston members of TACLS will take care of handling registration.

Motion was made that each state in region VII provides \$100 toward the expenses of the Region VII Student Representative to attend the ASCLS Annual Meeting. The motion was seconded and passed.

This year's student representative is Mellissa Nedri. This motion will provide $5 \times 100 = 500$ toward her expenses.

Jim Harris from the Texas Dept of Health in Austin will present a teleconference on Toxic Molds. The proposed date is November 8th or 15th at 4:00 p.m.

TnT Explosion is the name designated for the joint Texas-Tennessee Tea party to be held at the ASCLS meeting in Orlando. The meeting is scheduled for July 30 through Aug 2, 2002; the TnT Explosion is scheduled for Thursday, Aug 1, 8 - 10 p.m.

A motion was made to reimburse Duncan Samo for a 6' x 2-1/2' banner that advertises the TnT Explosion. The motion was seconded and passed.

The suggestion was made that host members (i.e., Texas and Tennessee members) buy a logo shirt to wear at the party. The cost of the shirt should be less than \$15.

A motion was made to increase the petty cash account of the Executive Secretary up to \$400 in order to cover mailing expenses of the newsletter. The motion was seconded and passed.
