

A Message from the President



What does it mean to be a laboratory professional? What are your responsibilities and duties? The Code of Ethics for the American Association for Clinical Laboratory Science lists three duties – duty to the patient, duty to colleagues and the profession, and duty to society. Under duty to the patient the code states "clinical laboratory professionals are accountable for the quality and integrity of the laboratory services they provide. This obligation includes maintaining individual competence in judgement and performance and striving to safeguard the patient from incompetent or illegal practice by others." To maintain competence in the dynamic changing medical laboratory, professionals are obligated to attend and participate in continuing education. Several continuing education opportunities are available this spring including the board meeting February 5th in San Antonio, a traveling seminar in Nacogdoches February 12th and the annual meeting in Corpus Christi, March 30 – April 2. Attendance at these or other continuing education programs is not enough.

A laboratory professional is obliged to "safeguard the patient from incompetent practice by others". That means as laboratory professionals, we must also encourage our coworkers to maintain competence and participate in continuing education. Tell them about the opportunities offered by TACLS and ASCLS. Ask them to join our organization and share their expertise. Pass on the information about the board meeting, the traveling seminar, the annual meeting and the other benefits of membership. See you in San Antonio on February 5th..
